



NOMINATION FORM FOR 2014-15 COMMITTEE POSITIONS

The Annual General Meeting of the ALBURY WODONGA MOUNTAIN BIKERS will be held on Tuesday 5th August at **6:00pm** at the Commercial Club, Dean St Albury.

All positions within the Albury Wodonga Mountain Bikers will be considered vacant at this time and nominations for all positions within the club, both formal and informal will be accepted.

As per the constitution, the following four roles form the 'Executive Committee' of the Albury Wodonga Mountain Bikers:

- President
- Vice-President
- Secretary
- Treasurer

(It is permissible for one person to fill more than one of these roles within the Executive Committee)

The Committee of the Albury Wodonga Mountain Bikers includes all roles comprising the Executive Committee as well as three other people. There is no constitutional requirement for any of the members of the Executive Committee or the Committee to fulfill other position within the club, although it may be advantageous to have the following roles filled by the three non-Executive (or Executive) members of the Committee.

- XC Coordinator
- DH Coordinator
- Trail Manager

The 7 positions comprising the 4 Executive Committee and the 3 extra committee people will be elected at this AGM and form the General Committee of the Albury Wodonga Mountain Bikers.

There are many other positions of responsibility in the club without which the Albury Wodonga Mountain Bikers could not function. The expectation is that nominations will be accepted and people elected into these other positions of responsibility at this AGM. These extra positions may include (but are not limited to):
